1.	Kindly advise print volumes, mono and colour. Can this be split between machines and A3/A4	Service Provider to find attached to this communique Addendum 1 which composes of Detailed Click Charges Breakdown
2.	The Monthly Rental fees must include all necessary cost including standard warranty, consumables, maintenance and servicing of equipment. There is a price for the "follow me printing" software, where must I put that pricing?	The "follow me printing" must be included in the Monthly Rental pricing.
3.	The Machine speed per copy must offer the minimum specification as required in the scope of works and technical requirements but can have a variance od up to 10% variation above the minimum specification for e.g.where 60ppm is requested a 65ppm can be proposed. You are requesting a speed of 36 pages per minute on the one machine. Will you disqualify us if I quote on a 35 page per minute machine?	The Service Provider's Machine speed per copy must offer the minimum specification or higher as required in the scope of works and technical requirements.
4.	You are requesting the cost per copy price plus full amounts for the volumes.	Service Provider to find attached to this communique Addendum 1 which composes of Detailed Click Charges Breakdown



	On the colour machines we are quoting on, there are different cost per copies, how will I be able to know what the volumes for the different machines are to determine the pricing? i.e. 35 page per minute and 65 page per minute machines are not the same pricing. Could you please specify the average volume the 65 page per minute machine currently does.	
5.	Is the monthly volumes for the total fleet per month. 25000 colour and 65000 mono? Or per device? If this is total monthly why does ECDC need such high-speed devices? Or does ECDC print mainly at certain times of the month?	There are many users printing large documents at a time, that's why we need the high speed printers.
6.	Staple finishing. What type of stapling? Corner/booklet/multi staples on the side?	ECDC requires the all the staple mentioned. Corner, booklet, multi staples on the side.
