Please elaborate whether we should supply additional pricing on Project Management service?</p>	<p>Annexure is E is critical and very relevant as it details the type of service offerings that comprises the Total Cost of the project.</p> <p>The type of service offering whether Project Management or otherwise must be detailed and stated for evaluation purposes.</p> <p>Bidder is to detail all your service offering and all the relevant costs in order to complete this project</p>
2.	<p>B. Datacenter Server/Storage Refresh & Business Continuity Implementation: Implementation of a dual site, fully redundant virtualized Hyper-V hyper-converged infrastructure. New hyper-converged platform should simplify daily operations and administrative tasks by combining Compute, Server, Storage and Virtualization into a single managed appliance providing full application availability.</p>	<p>Bidder is to supply a 3 tier solution based on the bill of materials and not the Hyper Converged Solution(HCI) as stated in scope of services. This is an error.</p>

<p>3.</p>	<p>In the tender document it states the below:</p> <p>4.1.2.5 Microsoft licensing</p> <ul style="list-style-type: none"> MS Enterprise Licensing <p>Will ECDC then provide all the necessary Microsoft licenses for the new Hypervisor servers?</p>	<p>Yes. Licensing will be covered under the MS Enterprise agreement</p>
<p>4.</p>	<p>What portion of the Tender is to be managed service is it the new infrastructure only?</p> <p>Is managed service meaning a 5 year maintenance agreement. EG “back to back with call home functionality with the hardware vendor” through Dimension Data with a defined SLA for the replacement of the equipment in the event of a failure.</p> <p>And is the Bidder to facilitate the hardware swap out.</p>	<p>The bidder must provide ECDC with 5 years maintenance support (in the form of an SLA) on the new infrastructure installed. In other words, if an issue or fault is encountered with the hardware then the successful bidder is responsible to deal directly with the vendor to either ensure a hardware replacement or resolution is found as dictated by SLA and Warranty.</p> <p>If the bidder wishes to provide an automated home call functionality for the hardware then it’s purely up to the bidder and the hardware vendor.</p>
