**1.6 Preferential Procurement**

This bid is subject to the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulation of 2022 as applicable to provincial government business enterprises as listed under schedule 3(d) of the Public Finance Management Act and the ECDC Procurement Policy as amended from time to time.

**1.7 Evaluation Criteria**

All submitted bids will be evaluated in the following 2 stages:

<b>Pre-Qualification</b>	Service Providers are to meet all the Mandatory Requirements in order to be evaluated further. Failure to submit the Mandatory Requirements as required will result in the bid being disqualified.

##### **Legislative Mandate**

ECDC draws its mandate directly from the Eastern Cape Development Corporation Act (Act 2 of 1997) and is led by the economic development priorities of the provincial government, as detailed in the Provincial Growth and Development Plan (PGDP), Eastern Cape Provincial Industrial Development Strategy (PIDS), the policy statement.

and budget speech of the Member of the Executive Council (MEC) of Economic Development, Environment Affairs and Tourism (DEDEAT).

Section 3 of the ECDC Act states that the Corporation shall “plan, finance, co-ordinate, market, promote and implement development of the province and its people in the field of industry, commerce, agriculture, transport and finance”.

#### 2. Background to the Project

The Eastern Cape Development Corporation, in line with its mandate of coordinating economic development, trade and investment in the province is supporting activities aimed at ensuring inclusive socio-economic development in the province. The support is provided in the form of facilitating development, providing development finance and enterprise support in line with the priority sectors as per the Provincial Economic Development Strategy.

The ECDC's has an intention of establishing a film value chain production infrastructure. This is based on the need for full beneficiation of the province in film production from Pre-production, Production, Post-production and Distribution. The direct contribution of the film industry to the economy of South Africa was estimated at R3,86 billion in 2021, according to the National Film and Video Foundation (NFVF) 2021 Baseline Research Report. An additional R3,31 billion is projected to have been generated through indirect (R946.07m) and induced (R2,36 billion) impacts, resulting in a total

contribution to the local economy of R7,18 billion. The Eastern Cape province has also seen numerous investments into film and television projects that have contributed to stimulating the development of the industry and its value chains.

As the Eastern Cape is a growing hub for the film industry. The ultimate objective is to attract major international series and film projects by providing world-class, international standard production sound stages, as well as a comprehensive backlot solution for shooting on standing sets. This feasibility study aims to set the platform and guide to this.

This project aligns with the ECDC's mandate, as articulated in the ECDC Act of 1997, of attracting new investors and positioning the Eastern Cape as the investment destination of choice. This project aligns directly with the provincial government's intention of fostering integration among Eastern Cape Development Corporation(ECDC), Eastern Cape Arts & Culture Council(ECPACC), Department of Arts, Sports Recreation & Culture(DSRAC), Eastern Cape Provincial Tourism Agency(ECPTA) and private sector partners in implementing projects. This is a legacy project, that provides a platform for a sustainable film industry in the Eastern Cape, driven by strong skills transfer and training program that runs in parallel to the studios.

### **3. Rationale**

High production costs are still the main stumbling block in increasing the output of the Eastern Cape film industry as most filmmakers do not have the upfront production cost funding needed to begin filming. Although the high costs relate to human capital, physical production equipment and facilities. Government intervention in infrastructure investment could significantly aid in reducing the risks faced by the emerging filmmakers and lower the barrier to entry for SMME film enterprises. The principle of public-private partnership of film infrastructure (between film practitioners & state) must guide the establishment of film production studio. Studies in the film industry have shown that infrastructure is a catalyst for the growth of the industry.

Thus far a lack of film infrastructure and logistic capacity and resources associated with bringing film equipment from other provinces are still the main stumbling block in increasing the output of the Eastern Cape film industry. Government intervention in infrastructure investment could significantly propel activities in this sector and reduce costs of filming in the province which adversely both the emerging and established filmmakers. It is envisaged that the establishment and running of this infrastructure will be via the public-private partnership model.

Another important aspect of the film industry value chain is the impact of the digital economy, digital media and the digital content era. The digital media environment has the influence of creating a more integrated and synchronised creative economy which could also be a platform for the creation of infrastructure towards the production, distribution and exhibition of South African and localised Eastern Cape content creation.

The rationale above articulates the ECDC position (in partnership with provincial key stakeholders) in pursuing a project to build a film industry value chain infrastructure in the province. This will ensure that more productions are attracted to the eastern cape province as critical infrastructure will be available.



#### **4. Scope of Services Required**

The ECDC is looking for an experienced business consultant to conduct a feasibility study towards catalysing a film value chain infrastructure in the Eastern Cape. The project is anticipated to be located in either the Nelson Mandela Metro or Buffalo City Metro. This will enable the ECDC to make an informed decision on the best approach to support the film infrastructure development value chain project.

### 5. Responsibilities and duties

Notwithstanding the fact that a description of the services has been provided above, ECDC shall be entitled to request additional services related to deliverables required to ensure the successful completion of the services set out above on such further terms and conditions as may be agreed between the parties in writing.

The service provider shall always faithfully and timeously carry out and perform the Services and shall use its best endeavours to properly conduct, improve, extend and develop the business of ECDC in the provisioning of the services.

## 9. ECDC facilities

A delay by the bidder in the performance of its delivery obligations may render the bidder liable to the imposition of penalties, unless an extension of time is agreed upon without the application of penalties.

the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed.
